DEPOSITS ARE NON- REFUNDABLE for any reason, other than the following exceptions: Your money will be refunded if an unforeseen problem arises with the puppy, not enough puppies of selected sex, or if the Breeder terminates contract. Breeder retains the right to terminate contract at any time.

Deposits and Final payments may be paid by cash, check (*except for Final Payments*), money order, Walmart to Walmart or credit card. Final payments are due when picking up the puppy or 1 week prior to shipping. Final payments made by PayPal must be made 2 days prior to picking up puppy. Shipping is not included and will be added to final payment.

If shipping is delayed due to a non or delayed payment, you will be charged for additional vaccinations and boarding from the estimated shipping date to the receipt of the final payment

Pick on puppy **MUST** be made by time the puppy has reached 7 weeks of age. The breeder retains the right to take 1st pick male and/or female of any litter. Picking order as indicated in this contract is after breeder chooses, unless otherwise stated. (ie: if states 1st pick, that would be 1st pick after breeder)
